Black Water Farms Issues: The Black Water Farms organizer has indicated his belief that since the operation is registered with the Michigan DNR, it falls within the Right-to-Farm Act and does not require a special use permit. The only animals which may be housed on the property will be his own four canines and no facilities for over-night stays or selling of food will be a part of this operation.

Parks & Recreation Plan Grant Issues: Much time has already been invested in the first phase of the proposed park. Costs and priority items have been estimated and the individual preparing the grant application has made suggestions based on her past experience. There will be three phases to the grant, but the first phase is required to be identified when the grant is filed.

On Tuesday, March 19, 2019, the Township Board will hold a public hearing to discuss the application for a grant to assist in funding the parks. The meeting will include potential funds to be expended. The date near the end of March is anticipated as the date for submission of the grant application.
